- **Enrollment fee must be paid at time of registration to hold a place in the class. Enrollment fee is non-refundable.**
- **Member scholarships and a limited number of needs based scholarships are available. Scholarship explanations and eligibility can be found on the back.**
- Membership status will be given once family has attended, and completed Concordia's New Member Class
- Tuition may be paid for the year, by the semester, or on a monthly basis.
- Members of Partner Churches are eligible for the partner member rates. Please check with your church to see if you qualify.
- Miscellaneous fees:
 - ✓ PTL fee (annual):\$10/family plus \$5/ enrolled student.
 - ✓ School lunches are available for a fee. Free and reduced lunches are offered to qualifying students.
 - ✓ Extended Care (before and after school) available for K-8 students
 - ✓ Athletic and instrumental music programs are offered for additional fees.
 - ✓ Purchase of Bible and Catechism may be required for some grade levels.
 - ✓ Gym clothes for some grade levels may be required.

At Concordia Lutheran School we seek to continually evaluate our programs in order to provide the best in Christian education utilizing all available resources this includes, but is not limited to, our fiscal responsibility. We seek to maximize existing potential

sources of income which can be utilized to benefit our school and improve upon the already high quality product. In light of this process, the School Board of Concordia Lutheran School has approved the following tuition policy to become effective for the 2020-2021 school year.

Prior to applying any and all possible scholarships, the per student base tuition rate for Concordia students will be \$5,600 for the 2020-2021 school year. All families are encouraged, but not required to apply for one or more of the scholarships offered by Concordia Lutheran School. These scholarships will be applied in the order identified within this policy provided the eligibility components have been met. Students MAY qualify for more than one scholarship.

The scholarships offered are as follows and will be applied in the order in which they are presented:

- 1) **Partner Scholarship** - Eligibility is determined by active membership at Concordia Lutheran Church. This is determined when the active membership policy approved by the Board of Education is applied. All active members will receive a Partner Scholarship not to exceed \$2000 per student.
- 2) **Choice Scholarship provided via the State of Indiana** - Eligibility is determined by guidelines as determined by the State of Indiana. Qualifying income levels will be made available once they have been provided to Concordia. **A current 1040 tax form (pg. 1) is required with this application.** Additional forms will need to be completed provided the scholarship is awarded.
- 3) **Scholarship Granting Organization (SGO)** - Eligibility is determined by income level equal to 200% of the Free and Reduced lunch income levels provided by the State of Indiana. These amounts will be available once they have been provided to Concordia. **A current 1040 tax form (pg. 1) is required with this application.** Additional forms will need to be completed provided the scholarship is awarded.
- 4) **Community Scholarship** – This scholarship is a needs based scholarship based upon income. This option is utilized when other scholarship opportunities do not apply or are insufficient. Amounts will be determined through an application, a meeting with the principal, and Board of Education approval based upon available tuition assistance funds. **A current 1040 tax form (pg. 1) is required with this application.** This scholarship is open to members and non-members.

Families MUST apply for scholarships in order to receive an award. In some cases a family may be eligible for multiple awards or no award. Applications will be included in registration materials and will be made available upon request and on the school website.
