Prior to applying for any and all possible scholarships, the per student base tuition rate for Concordia Students for the 2021-2022 school year will be \$5,600.00 for grades 1-8 and \$3,850.00 for Kindergarten. All Families are encouraged, but not required to apply for one or more of the scholarships offered by Concordia Lutheran School. These scholarships will be applied in the order identified within this policy provided the eligibility components have been met. Students MAY qualify for more than one scholarship.

The scholarships offered are as follows and will be applied in the order in which they are presented. Please check the box of any or all scholarships you wish to apply for. Please fill out the required paperwork and/or questions for each scholarship you wish to apply for. Scholarships are available to students in Kindergarten to 8<sup>th</sup> Grade.

Partner Scholarship- Eligibility is determined by active membership at Concordia Lutheran Church. This is determined when the active partner policy approved by the Board of Education is applied. All active partners will receive a Partner Scholarship not to exceed \$2,000.00 (1<sup>st</sup>- 8<sup>th</sup> grade) or \$250.00 (Kindergarten) per student.

Choice Scholarship- Eligibility is determined by guidelines determined by the State of Indiana. Qualifying income levels will be made available once they have been provided to Concordia. Additional forms will need filled out at a later date for this scholarship.

- Household Size Assurance Form
- 1040 Tax Form (2020 must include all dependents listed and your adjusted gross income)
- Additional forms for income or household size changes on your tax form (not required by everyone)

Scholarship Granting Organization (SGO): Eligibility is determined by income level equal to 200% of Free and Reduced lunch income levels provided by the State of Indiana. These amounts will be available once they have been provided to Concordia. Additional forms may need filled out to receive this scholarship.

Required forms:

- SGO Application
- 1040 Tax Form (2020 must include all dependents listed and your adjusted gross income)

Community Scholarship: This scholarship is a needs based scholarship based upon income. This option is utilized when other scholarship opportunities do not apply or are insufficient. Amounts will be determined through an application, a meeting with the principal, and Board of Education approval based upon available tuition assistance funds. This scholarship is open to members and non-members.

Required forms:

- 1040 tax form (2020 must include all dependents listed and your adjusted gross income)

Families MUST apply for scholarships every year in order to receive an award. In some cases a family may be eligible for multiple awards or no award.
